5. Chapter must be formatted in Calibri, and if you do not have Calibri, then Times New Roman.
6. Beginning of each paragraph must be indented.
7. Maximum length of chapter 2500 word count (unless you are granted special permission.)
8. Chapter must be submitted in Word.
9. Each page must be clean with no page numbers or other lettering in the header or footer of the page.
10. When you submit your final piece, title the document: FirstNameLastNameFinal, such as LisaShultzFinal.doc.
11. If your chapter is submitted properly and is accepted for Volume Two, your cost is \$375 in one lump sum or four installments of \$100. You will receive 10 complimentary copies of the book and the ability to purchase bulk orders at wholesales pricing of \$9.99 to give or sell. List price of the book is \$19.95. You will however be expected to purchase at least one copy of the book on Amazon for our best selling campaign on the day selected and participate in our marketing strategies to ensure success of the book.
13. Submission deadline for Volume II is Tuesday, February 15, 2011 at Midnight OR sooner depending on receipt of 50 approved submissions for publication. Submissions will be considered in the order they are received.
